Titomic Limited (ASX: TTT) ("Titomic" or "Company") is pleased to announce the successful sale of an Integrated Spray Booth (System) to Perron038 for \$710,000, which will house a roboticised Titomic D623 medium-pressure cold spray unit. It has been agreed that the System will be delivered and paid for by the end of 2023.

Located in the Netherlands, Perron038 is a research and development facilitator that connects high-tech companies, educational institutions and research companies for collaborative development.

One such collaborator will be Windesheim University of Applied Sciences (Windesheim), a Dutch vocational university with a student base of over 25,000.
