**Titomic Limited (ASX: TTT) ("Titomic" or "Company")**, a leading manufacturing technology company specialising in advanced manufacturing and coatings, is pleased to announce the sale of a Titomic Integrated Spray Booth ("ISB" or "System") to EPCOR.

The ISB was sold to EPCOR for EUR 310,000 (AUD 516,615) and is expected to be delivered and installed in the coming months.

EPCOR is a subsidiary of Air France Industries and KLM Engineering & Maintenance and is specialised in maintenance, repair, and overhaul activities of pneumatic aircraft components and Auxiliary Power Units (APUs) of a wide range of aircraft, such as the Boeing 737 Next Generation, 777, and 787. EPCOR performs 300+ APU shopvisits and over 3,500 component shopvisits per year for its 70+ customers.

EPCOR will actively start developing cold spray repairs for aircraft parts in co-operation with Technical University Delft and the Netherlands Aerospace Centre.

The ISB, a medium-pressure cold spray system, occupies a niche between the D523 and TKF 1000. It excels at depositing dense, high-performance coatings for aerospace and automating metal part restoration, but is not intended for additive manufacturing, unlike the TKF 1000.

Titomic's customer and market oriented product line, demonstrated by the purchase of this capability-specific ISB by EPCOR, underscores the Company's commitment to meeting customer needs within aerospace.
